THE PRESIDENT'S CORNER

Many members have asked me how AFSCME chooses who they are going to endorse. As the PEOPLE Chairman for Region 3 and the person who organizes the candidate screening process for the primary and general elections, I can thoroughly answer this question. AFSCME Council 25 invites candidates to a screening process at a set time and place before both the primary and the general election. These candidates are screened and asked specific questions that focus on issues that affect working men and women, especially those who work for AFSCME. Based on the answers given in the screening process, a recommendation is made whether to endorse the candidate or not to endorse by the screening committee. This recommendation is brought to the AFSCME Council 25 Executive Board and voted on. For any seats not attended at the AFSCME screening, the AFL-CIO screening recommendation takes the place of the screening committee and is used as the recommendation.

Macomb County Commissioner Races Key to Successful Contract Negotiations

The outcome of the November 2nd election could have a major impact on the success or failure of upcoming contract negotiations. There are five county commissioner board seats that will be filled by newcomers this November. In District 1, the seat held by long-time friend of labor Ralph Liberato will be filled by a newcomer. In District 4, incumbent Mike Walsh was defeated in the primary. In District 14, incumbent Kurt Kramer was defeated in the primary. In District 19, incumbent Jim Perna was defeated in the primary and in District 23, incumbent Roland Frascchetti was defeated in the primary. AFSCME is hoping to add a number of labor-friendly commissioners to the board. We are highly recommending you vote for the following candidates. These are candidates who have a proven record of either voting on issues in the past that benefit AFSCME 411 members or who have a strong commitment to labor. AFSCME does not endorse candidates based on their party affiliation. AFSCME endorses candidates who have a history of voting on issues that are going to benefit our members. We are endorsing these candidates because we feel they will assist us the most in our upcoming contract negotiations.
